1. Alcohol is **prohibited** in Park.
2. Fires **ONLY** in designated areas.
3. Notify Police Dispatcher at least 1 hour before entering the park. (777-2231)
4. Bring own firewood. (You may use our wood if there is any on site.)
5. Carry jugs of water to make sure fire is out when you leave. Remove any and all trash upon departure.
6. Keep activities quiet and orderly.
